- MHS Assembly has been gathering leadership of Anabaptist health and human service ministries since 1952. The 2024 MHS Assembly was held March 12 – 14 in Savannah, GA, with a theme of Building Up. Featured keynote speakers included Dr. Betty Pries, Dr. Michaela O'Donnell, Chad Horning, and Jeremy Kauffman. Each day's agenda included break-out sessions and opportunities for networking. - MHS Consulting serves MHS Association members and nonmembers in the health and human services sector; primarily providing resources in governance, executive searches, executive coaching, interim placement, strategic planning and positioning, and operational, financial, and market assessments. Our services are available to churches, conferences, church agencies, and other nonprofit organizations.
- The MHS Association Board of Directors and MHS Association Staff continue to advance diversity, equity, justice, and inclusion (JEDI) initiatives. - MHS Association annually offers two educational scholarships. The Elmer Ediger Memorial scholarship is given to four students in programs of study in the field of behavioral health or

developmental disabilities. Each scholarship is \$3,000. The Miller-Erb scholarship is given to two undergraduate students pursuing a Bachelor of Science in Nursing (BSN).
